Extra-Curricular Transportation WAIVER

If parents/guardians provide transportation from these events, they must be aware of the following:

- Where a parent/guardian provides transportation for their student to/from a scheduled event, the parent/guardian shall assume all resulting liability and the school shall assume no liability.
- Where a parent/guardian or another responsible adult designated by a parent/guardian transports students other than their own to/from a scheduled event, the parent/guardian or designated responsible adult transporting the student shall assume all resulting liability and the school district shall assume no liability.

Transportation Liability Waiver

I have attended a pre-season meeting to discuss this waiver and read the OEHS Extra-Curricular Policy and agree that I shall assume all liability for negligently caused injury resulting from the following situations:

- Where I transport my student to or from a scheduled event;
- Where I transport other students to or from a scheduled event;
- Where I, as a parent/guardian, give permission to a responsible adult to transport my student to or from a scheduled event. I have explained to the designated individual that he/she will assume all liability.

I also agree that Otto-Eldred School District shall assume no liability whatsoever for negligently caused injuries resulting from the above situations or any other situation where contracted transportation is not being used to transport students.
